



Figure 9. Percent of individuals for each interest level for future SOAR participation




Build enduring partnerships with shellfish farmers to accelerate the restoration of coastal ecosystems and create a thriving and diverse industry that is resilient to future threats.





The SOAR Resiliency Fund

Farmer engagement in shellfish restoration, marine conservation, or environmental outcomes

Projects that increase farmer engagement in shellfish restoration, marine conservation, or enhance environmental outcomes of farming

Efficient farming operations

Projects intended to improve efficiency and cost savings in farming operations and/or provide increased or enhanced industry support services or reduced carbon footprint

Expanding access to aquaculture training and jobs

Projects, such as training, mentorship, or programs, that support communities not already engaged in the aquaculture and restoration industry

Resiliency Fund- Awards

83 Projects Awarded

- 2021- \$1,000,000
 - 36 projects (28 small awards for industry led projects and 8 large awards)
 - Across 16 states
- In 2024-\$898,000
 - 47 industry-led projects
 - Across 18 states

Next Steps- Best Management Practices



- Title: "Best practices for using adult diploid oysters in oyster restoration and enhancement projects: building on SOAR"
- Purpose: provide guidance for resource managers, industry and non-profit partners to establish an implement a SOAR-like program
- Share lessons learned from TNC and Pew Charitable Trusts
- Work in progress (expected publication in late 2025)




Next Steps- Identifying Barriers & Sustained Funding



- Identify sustainable funding within an agency.
- Support bills that could provide funding to an agency to for carrying out a SOAR-like initiative (e.g. state NRCS programs)
- Address barriers to native shellfish restoration such as permitting challenges and shell substrate availability


Future of SOAR



Engage federal agencies to secure long-term funding for SOAR

- High level engagement with USDA, NOAA, and NRCS
- Looking to the Farm Bill to support NRCS Programs
- Secure long-term funding for 3 state programs

Resiliency Fund


- Established March 2021
